<sup>3</sup> Vehicles exceeding gross weight limits for their DPW Vehicle Class, must leave a deposit, be weighed in and out and will be charged the Minimum Charge or Rate Per Ton, whichever is greater. An estimated deposit is required to cover the cost of the load, no less than \$30.00.

**\$46.10/Ton General Refuse**

Any "solid waste" means non-hazardous, non-liquid, rubbish, garbage, and refuse. Solid waste does not include the following: human body waste, medical waste, organic waste generated in the production of livestock and poultry, liquid waste, ferrous or nonferrous scrap, slag or slag products, yard waste, tires, computer monitors or any other waste regulated by State Statute or as defined by the Director.

**\$75.00/Ton Large Tanks**

Any bulk tanks generally 250 gallons or more.

**\$75.00/Ton Trees and Stumps**

Yard wastes as defined by PA 451 are prohibited.

**\$300.00/Ton Troublesome Plastics**

Any plastic, plastic film, Styrofoam, insulation, light paper or fine particle material that potentially poses an operational hazard.

**\$55.00/Ton Dead Animals**

Dead animals from agricultural operations, road kill or other sources requiring special management.

**\$55.00/Ton Mobile Homes, Campers, Trailers, and Boats**

Bulky items that require special handling including equipment and labor to manage. All appliances in mobile home or trailer are to be removed.

**\$20.00/Appliances**

Any household or commercial appliances delivered for disposal or management.

**\$20.00/Mattress**

Any household or commercial mattress or box spring delivered for disposal.

**\$3.00/Propane Tank**

Any propane tank 20 lbs. or less.

**\$25.00/Propane Tank**

Any propane tank over 20 lbs.

**\$4.00/Tire**

Automobile, Pickup Truck, Motorcycle, ATV, etc. (any tire 42 inches or less).

**\$6.00/ Large Tires**

Any large tire not from an automobile or pickup truck (43-50 inches)

**\$69.00/Ton Cut Tires (with one ton minimum)**

Amounts greater than 15 cut tires or 30 pieces.

**\$20.00-\$50.00 Televisions**

Any electronic video display device with a viewable screen of 4 inches or larger.

Kent County Residents 27" and under \$20.00

Kent County Residents 28" and over \$40.00

Non Kent County Residents 27" and under \$30.00

Non Kent County Residents 28" and over \$50.00

**\$12.00/Vehicle Gross Weight Verification**

Weighing of any vehicle, truck trailer for the purpose of determining or verifying gross weight only.

**\$45.00/15 minute increment After Hours Service Fee**

After closing hours, the department may refuse the admittance of any additional customers.

Customers that remain on the premises will be charged an additional tip fee to cover extra manpower and equipment costs.

**Material Recycling Facility Only**

\$70.00/Ton Kent County recyclable materials

\$75.00/Ton Non-Kent County recyclable materials

\$80.00/Ton Transfer Trailers of recyclable materials

\$200.00/Load Rejected Loads of recyclable materials

**Special Application**

**South Kent Landfill Only**

**\$5.00-\$35.00/Ton Contaminated Soils, Foundry Sands, Saw Dust, Ash \***

Any matter contaminated by petroleum, mineral waste from castings or plating operations, which are non-hazardous, as outlined in PA 451, and also meet all rules set forth in the "Policy on the Use of the Kent County Solid Waste Disposal System". Prior approval of rate is required.

**\$18.00/Ton Sludge \* Call for rates, prior approval required**

Any sludge (e.g. municipal water or wastewater sludge, paper processing sludge, industrial sludge, food processing sludge or by-products), which is non-hazardous, as, outlined in PA 451, and also meets the "Policy on the Use of the Kent County Solid Waste Disposal System". The Director shall calculate the actual cost using a percent of solids in the sludge and/or environmental surcharge based on the chemical or physical characteristics of the sludge. Prior approval of rate is required.

**\$28.50/Ton Approved Charity \***

Any charity as approved by the Board of Public Works

Notes:

1. All rates are charged by the ton unless otherwise designated.
2. Rates by Special Application designated with an asterisk are for South Kent Landfill only.
3. All rates measured by the ton will be charged a \$.50/ton environmental and safety programs fee.
4. All rates measured by the ton will be charged a State of Michigan fee – Soil & Sludge \$.12/ton, C & D \$.24/ton, all other materials - \$.36/ton.
5. All rates measured by ton and originating in Kent County will be charged \$1.68/ton Kent County Solid Waste Surcharge.
